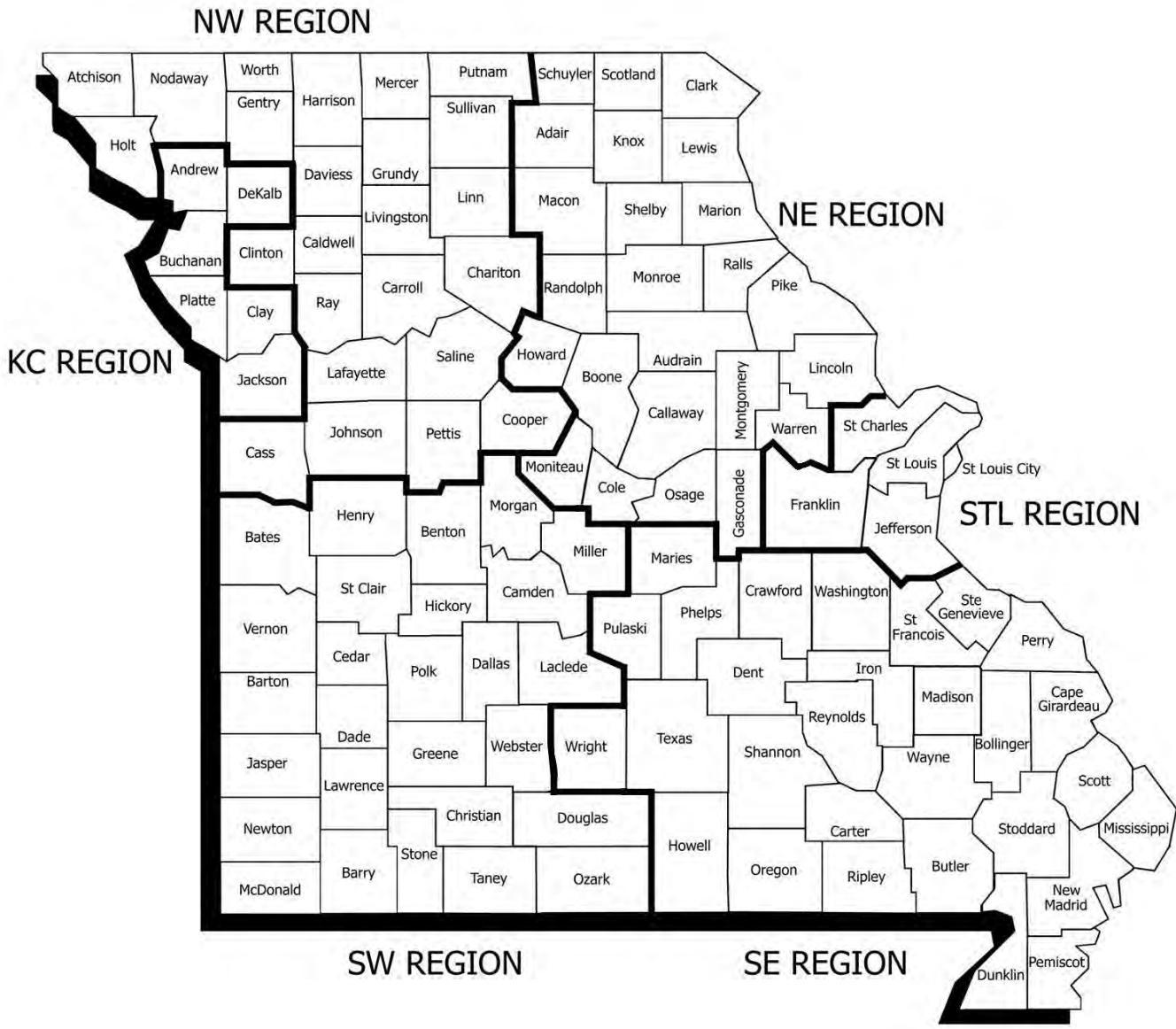

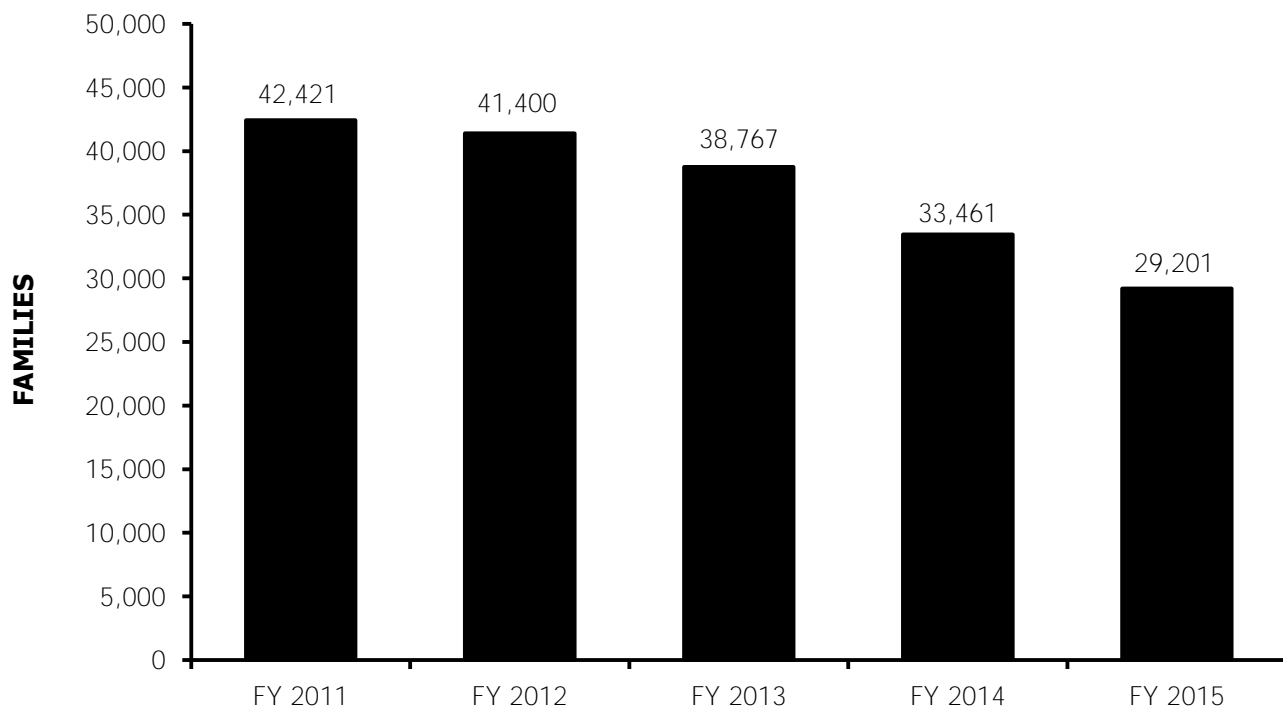

Department of Social Services Regions**

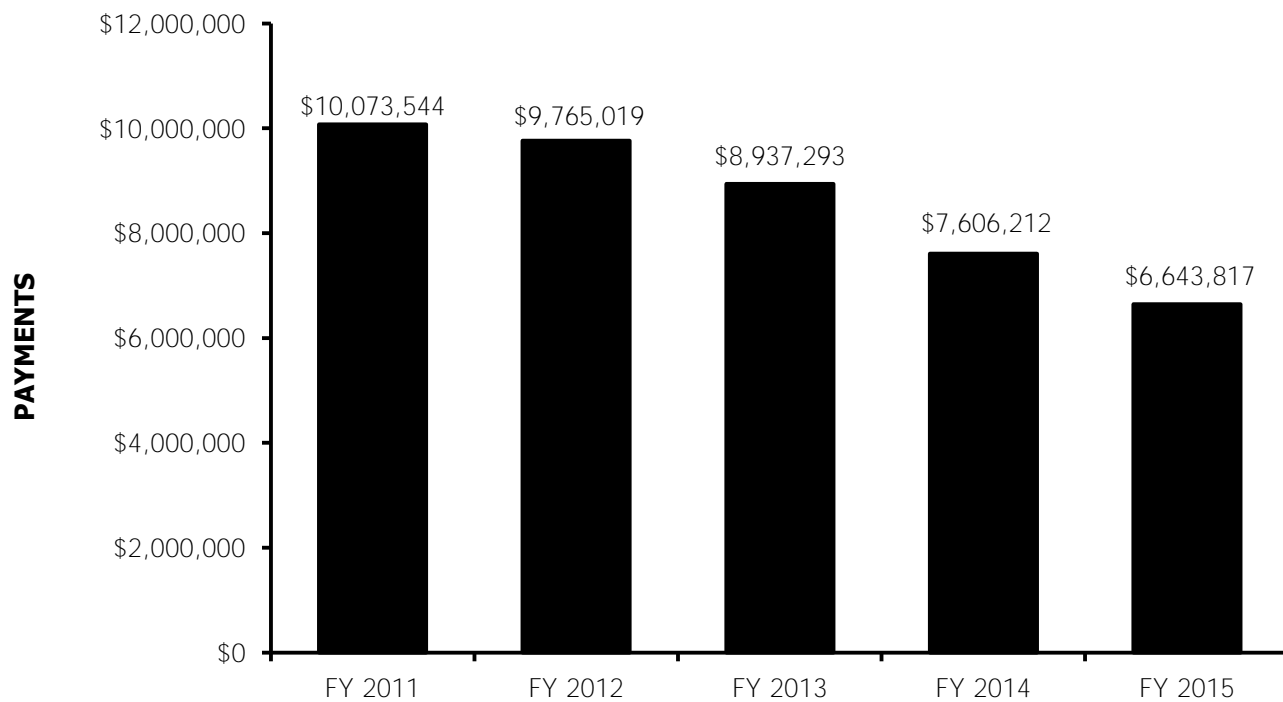

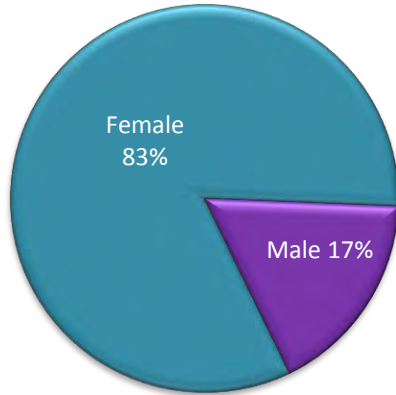

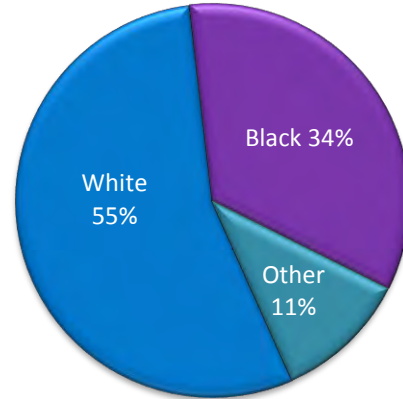

Figure 4. Representative Missouri Temporary Assistance Characteristics June 2015

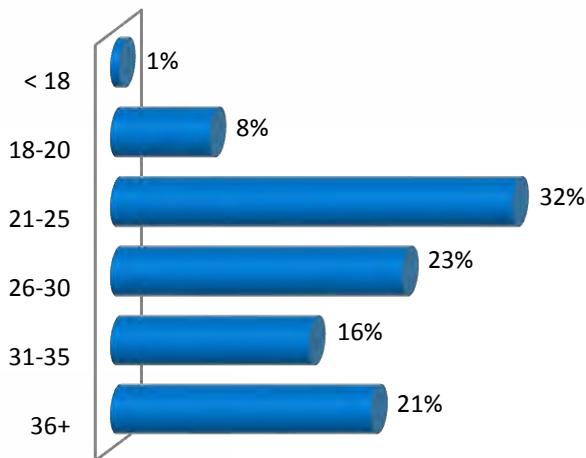
Gender of TANF Parent(s)/Caretaker(s)



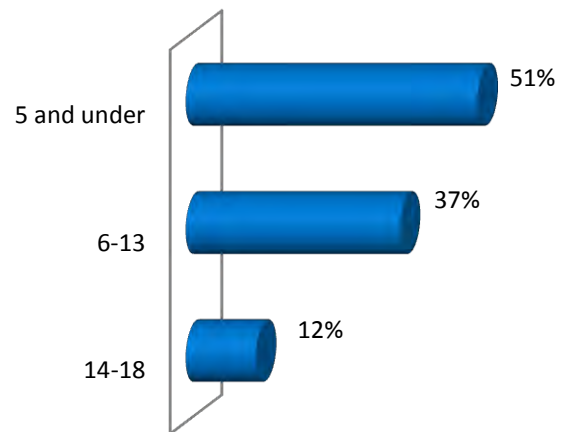
Race of TANF Participants



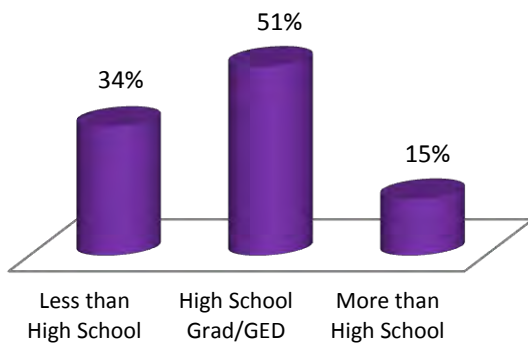

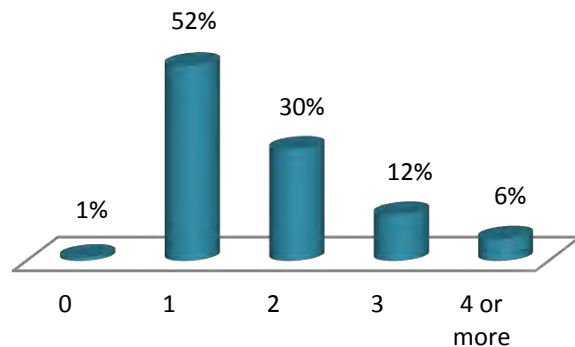
Age of TANF Children

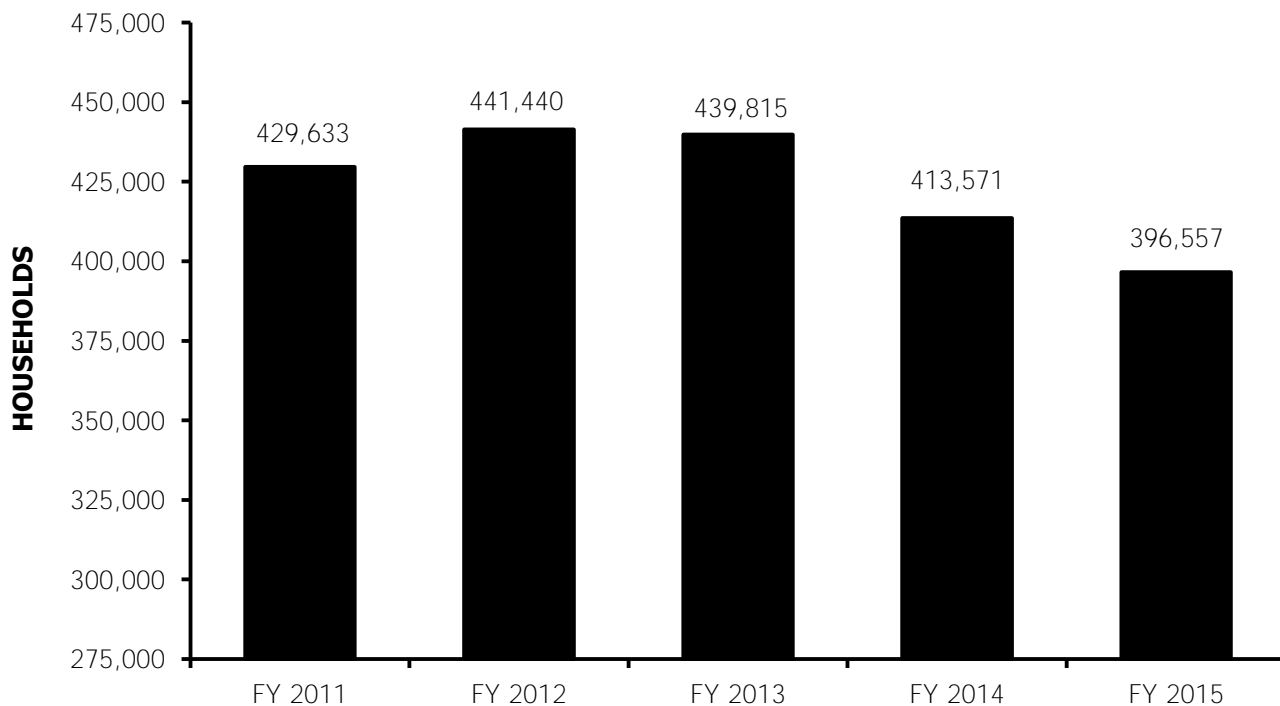

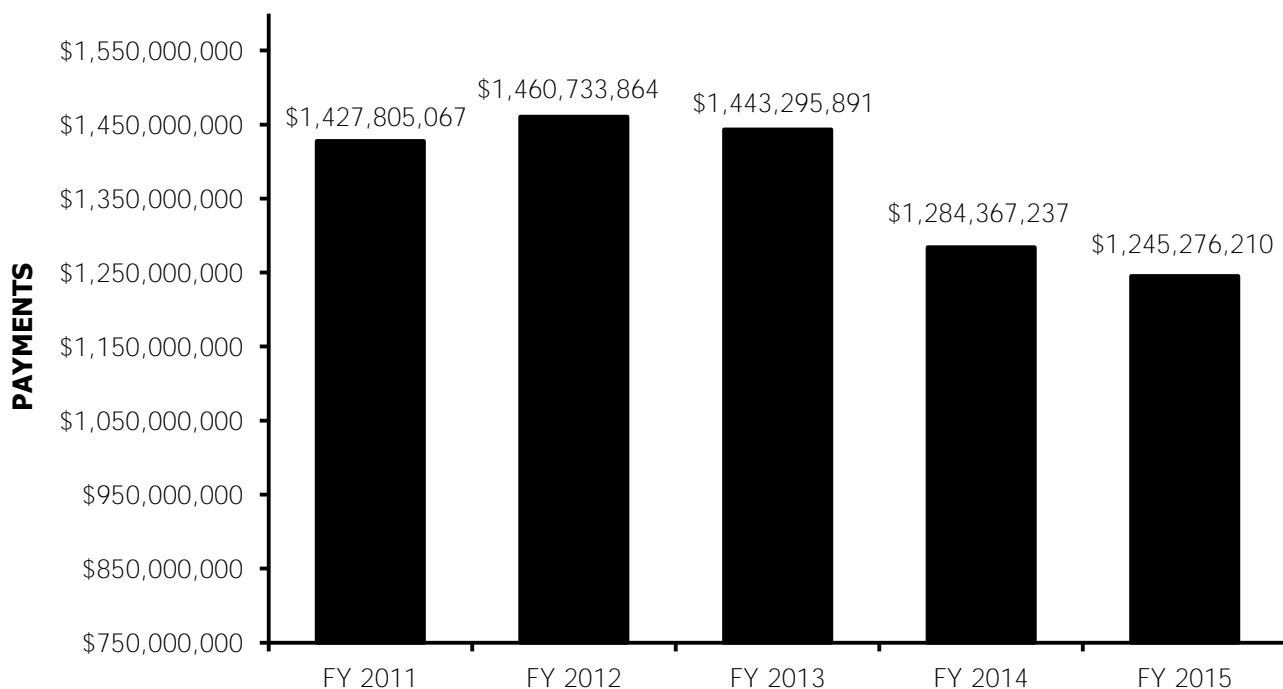

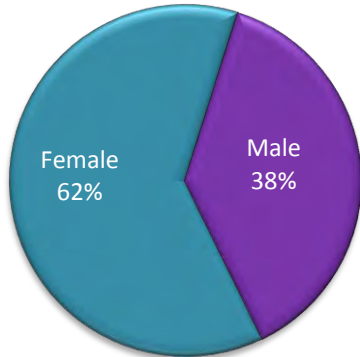

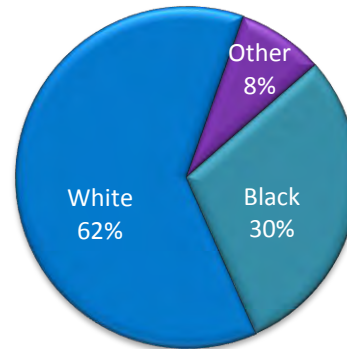

Gender of Adults Receiving Benefits

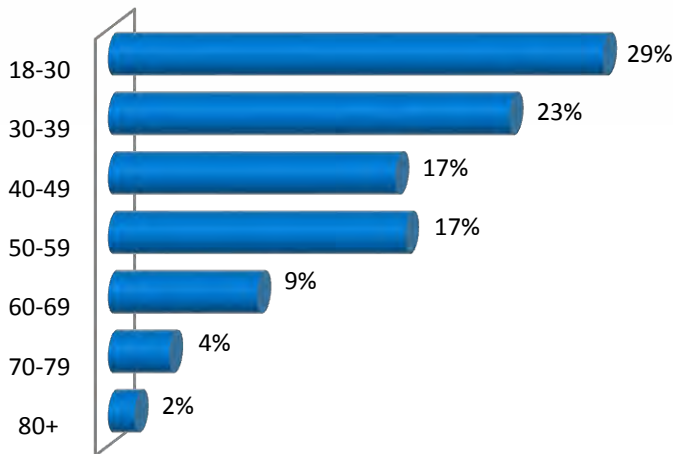


Race of Individuals Receiving Benefits



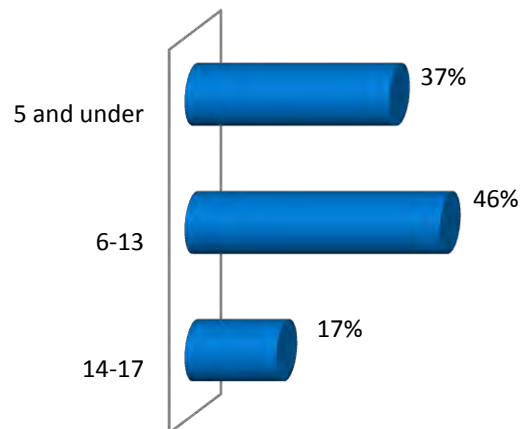
Age of Adults Receiving Benefits

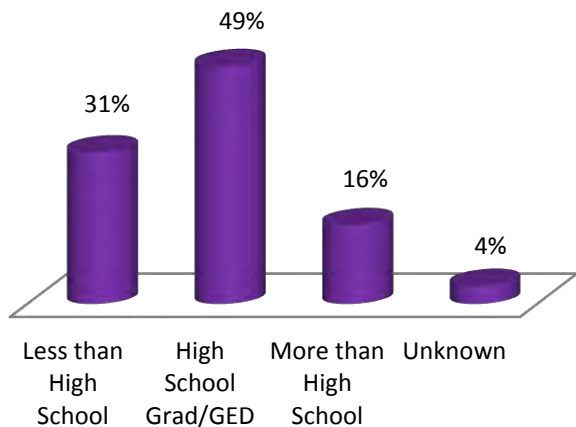
Age of Children Receiving Benefits

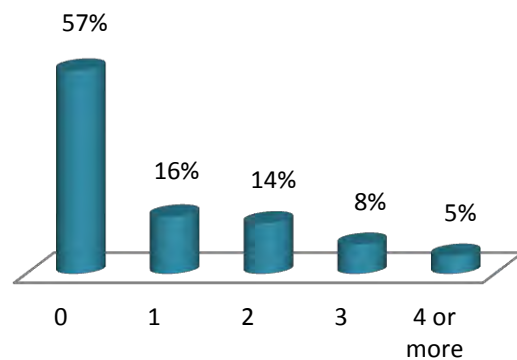
Education of Adults Receiving Benefits
