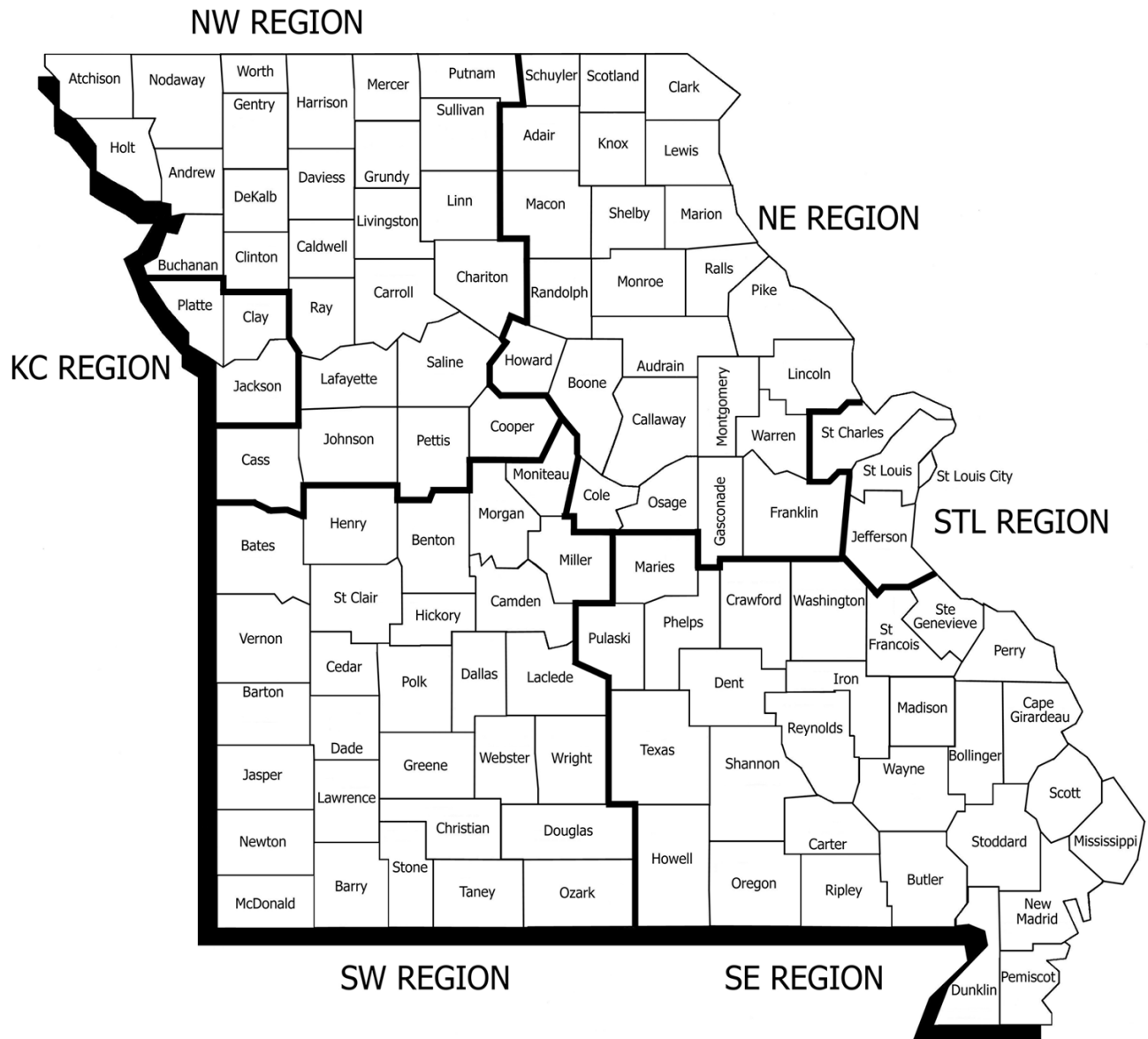

Average Monthly Caseload Fiscal Years 2005 - 2009

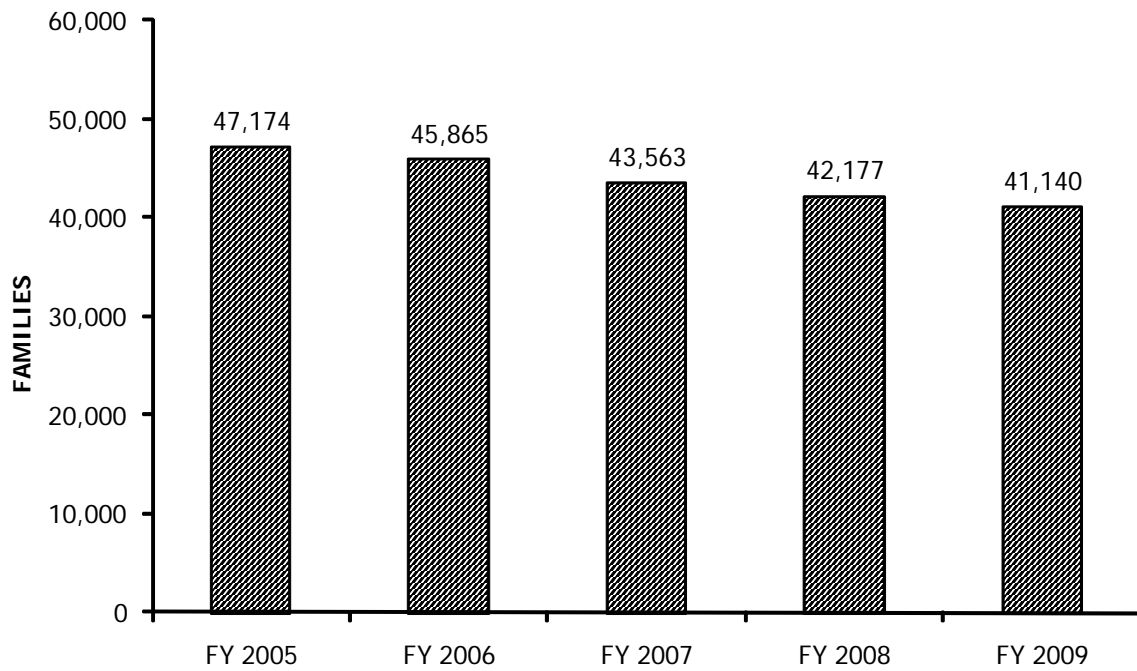
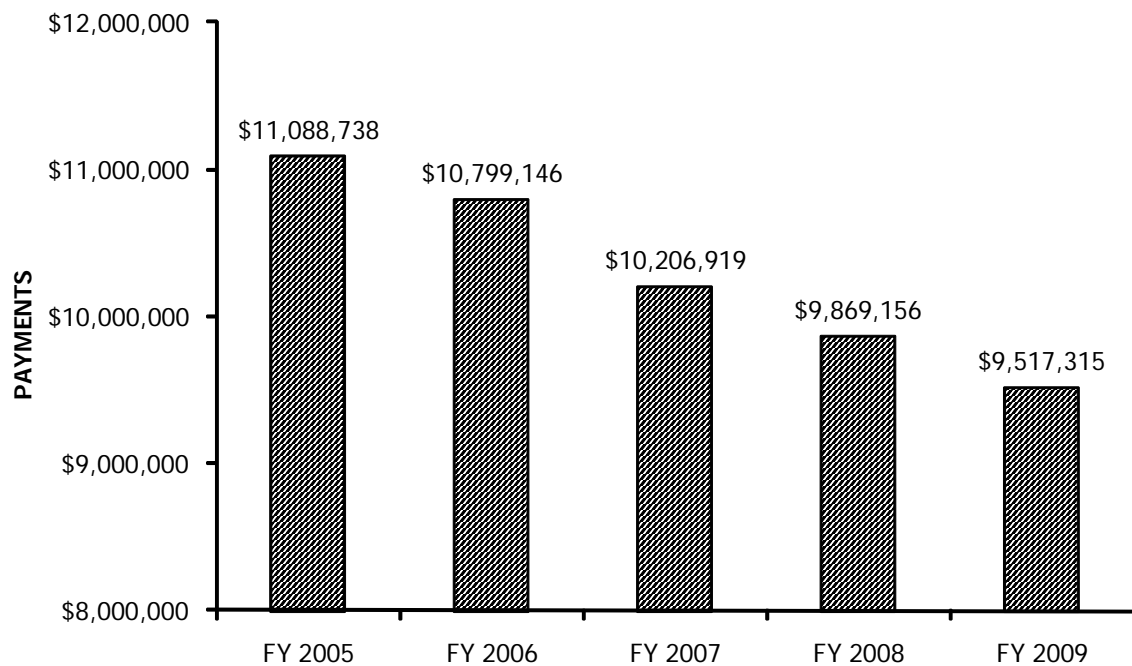


Figure 3. Temporary Assistance

Average Monthly Caseload Fiscal Years 2005 - 2009

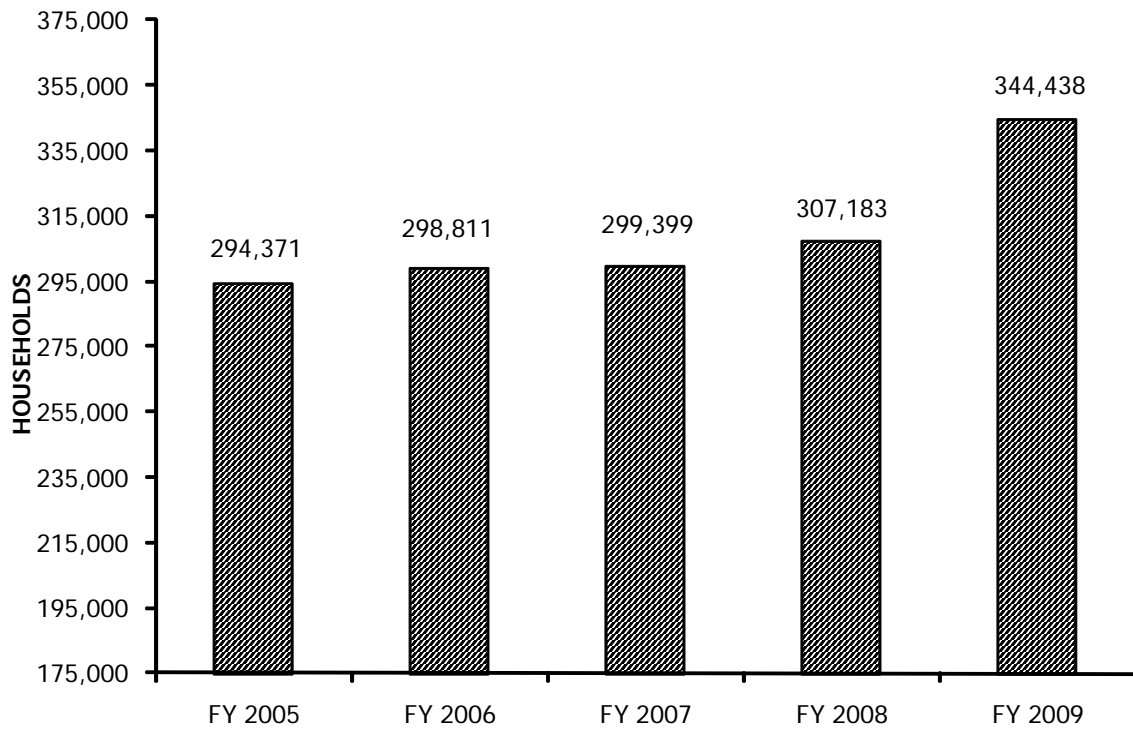
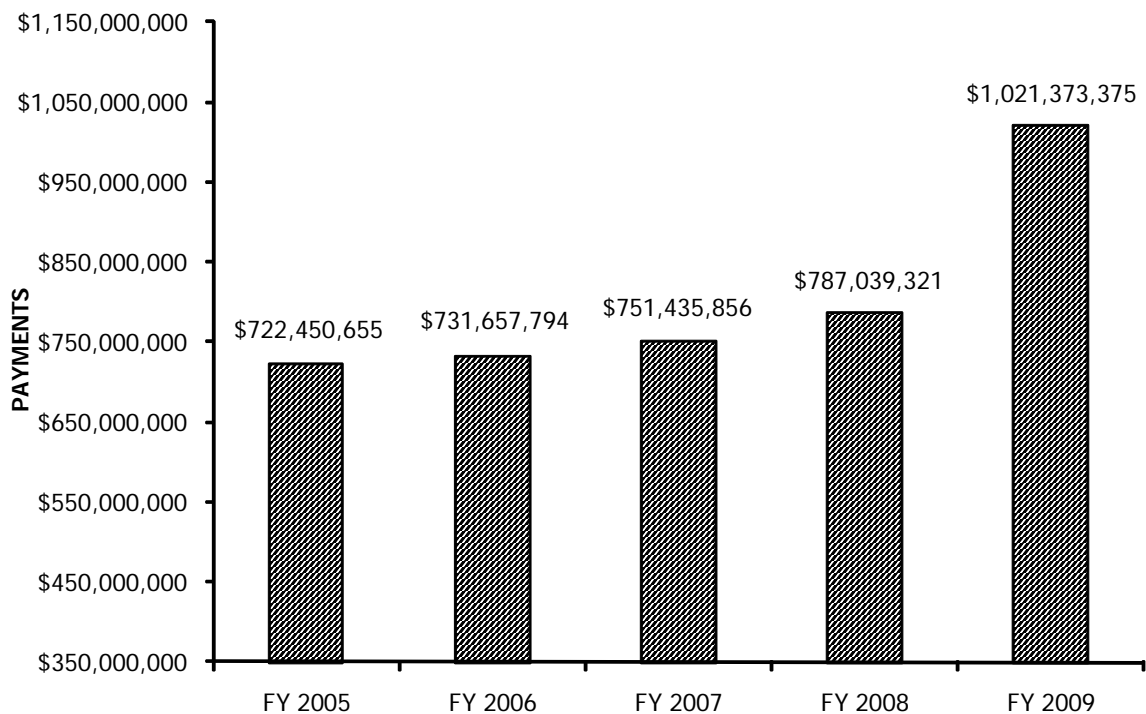


Figure 6. Food Stamps
