- Agency Spotlights:
 - Lydia's House: Karen Kirk, STL City and STL County. They have updated their mission statement after 28 years. They desire to meet the gap in services for domestic violence victims between the shelter stay and finding financial stability. They have served half a million safe nights. Cost free housing for survivors and their families. They provide comprehensive and community services to immigrants. They take care of their housing costs for two years. They are a pet friendly site. They offer many support services. They have a children's program and an in house medical center which is 24 hours. They have their largest gala coming up soon. Their building that had fire damage about a year ago is almost ready to reopen. One of their other buildings had a water main break in the front of it.
 - Martha asks if they accept referrals from other areas or if it's only STL. They do accept referrals from other cities/counties.
 - Legal Service of Eastern MO: Laura Halfmann- Morris. Their main office is in STL. They provide free legal services. Their family law program is their largest program where they provide free services for DV Victims and SA Victims. They also have social workers on staff for those who need assistance while going through the court process. Last year they had over 4,500 calls for services. They closed over 1,000 case in 2023 for about 750 survivors. Every county in Missouri have a Legal Aid program which offers services for survivors of DV. They have a holistic staff to be able to provide all the services or referrals necessary for survivors. They are available for presentations on the basics of family law for agencies.
