DVSS Agency Highlights -

Mid Mo Legal Services – Kirsten Dunham – MMLS is one of four legal aid organizations in Missouri. Main Office in Columbia and an office in Jefferson City. Serve 11 counties. Provide free legal services to low income and survivors of DV and SV. 812 cases last year. Helped almost 2000 people last year. MMLS also provides legal information including 239 veterans at the Veteran's Hospital in Columbia. Provide clinics for attorneys to help extend resources. Income and asset limits up to 125% of the poverty level, but in some cases, up to 200%.

AWARE Barnes – *Jewish Hospital* – *Zolia* Rendon-Ochoa – *Program within the hospital working with patients and employees dealing with DV. Meet with people throughout the hospital and then follow up with them. Spanish speaking clients have increased significantly and adjustments made to meet those needs.*

Cope – Judith Kile – 28 bed DV Shelter. 30 day program to start out with, but have the ability to stretch that out as needed. Case management, crisis intervention, set clients up with medical needs, assist get documents like birth certificates or SS cards. Action safety planning immediately upon contact. Court advocacy, and additional programs needed to succeed in society. Last year, 98 people served – 72 adults and 16 children.
