Executive Summary

#### **Missouri Department of Social Services**


The Department of Social Services (DSS) was created in 1974 to serve as an umbrella agency, coordinating programs to provide public assistance to children and their parents, access to health care, services to the elderly and specialized assistance to troubled youth. In 2000, the Division of Aging within DSS was abolished, and programs to provide services to the elderly were transferred to the Department of Health and Senior Services. While many DSS programs give needed financial assistance and services, others work to strengthen families and to move them from dependency to self-sufficiency.

The Director of DSS is responsible for the overall administration of programs within the department and determines priorities and initiatives for the agency. There are four program divisions within DSS responsible for assisting Missouri's most vulnerable citizens: Family Support Division, Children's Division, Division of Medical Services and Division of Youth Services. There are four administrative support divisions within the department: Division of Budget and Finance, Information Services & Technology Division, Division of General Services and Division of Legal Services.




#### Family Support Division

• Child support collections increased by 6.5 percent in FY 2004, to \$508.8 million from \$477.7 million in FY 2003. Of the 381,629 FY 2004 child support cases, 64,750 (17.0%) were related to cases of Temporary Assistance, while 9.5 percent of collections were Temporary Assistance related. [Table 3, page 18]





After decreasing for two years in a row, Temporary Assistance expenditures increased in FY 2004.
 Expenditures rose 3.7 percent, from \$131.3 million in FY 2003 to \$136.1 million in FY 2004. The Temporary Assistance average monthly caseload also increased in FY 2004 compared to FY 2003, up 2.5 percent to 47,796. [Table 4, page 20]





• Food Stamp expenditures and caseloads continued to increase steadily in FY 2004. Annual expenditures rose 22.4 percent and the average monthly caseload increased 15.8 percent from FY 2003 to FY 2004. [Table 5, page 22]






- General Relief (GR) provides assistance to needy and medically unemployable adults who cannot qualify for any other type of assistance. The average monthly GR caseload rose 1.3 percent from 3,222 in FY 2003 to 3,263 in FY 2004. The Missouri legislature did not appropriate funds to pay for GR cash grants in FY04. There were expenditures of \$8,120 in July 2003 for the last cash grants that were paid. GR recipients continue to be eligible for healthcare coverage through the Medicaid program.



- The Supplemental Assistance program includes Supplemental Security Income and State Supplementation (SSI MO) and Missouri State Supplementation Only (MO SUPP). The average monthly Supplemental Assistance caseload decreased 15.4 percent, from 488 to 413, while expenditures dropped 9.0 percent from FY 2003 to FY 2004. [Table 7, page 26]

#### Children's Division

- Block grant child care expenditures totaled \$157.1 million in FY 2004. [Table 8, page 32] The following types of child care are provided:
  - family-centered services (FCS), alternative care (AC), children's treatment services (CTS), and intensive in-home services (IIS): child care for children who have been or who are at risk of being abused or neglected;
  - adoption subsidy: child care for children who have been placed in adoptive homes and are receiving adoption subsidy payments due to special needs; and
  - income maintenance: federally funded child care for low-income families engaged in education, training or employment activities, or for children with special needs.



• Children's services expenditures totaled \$197.7 million during FY 2004, a 1.6 percent decrease from FY 2003 expenditures of \$201.0 million. The majority of expenditures were for rehab option (\$58.5 million), adoption subsidy (\$56.6 million), and foster care (\$34.5 million). [Table 10, page 36]



• During FY 2004, 56,538 child abuse and neglect incidents were reported, a 0.4 percent increase over FY 2003. Of the FY 2004 reported incidents, 11.6 percent were substantiated. [Table 12, page 44]

#### Division of Medical Services


 Medicaid paid claims continued to climb in FY 2004 to over \$4.8 billion. The majority of Medicaid paid claims (69.1 percent) were for pharmacy, hospitals, managed care and nursing facilities expenditures. [Table 14, page 52]



• Based on the average monthly number of Medicaid recipients, the most used services during FY 2004 were managed care (444,371 recipients per month), pharmacy (272,828 recipients per month) and physician related (209,756 recipients per month). [Table 15, page 56]

#### Division of Youth Services

- During FY 2004, the Juvenile Court Diversion program provided 4,006 at-risk youths with services aimed at diverting them from commitment to the Division of Youth Services.
- The number of youth committed to the Division of Youth Services during FY 2004 was 1,277, a 7.0 percent increase over FY 2003 commitments. Recommitments accounted for 8.1 percent of all commitments in FY 2004, compared to 8.5 percent in FY 2003. [Table 16, page 64]



- From FY 2003 to FY 2004, the number of commitments due to law offenses increased by 6.1 percent from 1,093 to 1,160, while commitments due to juvenile offenses increased by 17.0 percent from 100 to 117.
- The number of female offenders committed increased by 23.7 percent from FY 2003 to FY 2004, representing 18.8 percent of all commitments.

The Director of the Department of Social Services is responsible for the overall administration of programs within the department and determines priorities and initiatives for the agency. The Deputy Director has the responsibility and authority to act in the Director's absence, and reviews all legal, budgetary and financial aspects of the department.

There are four program divisions within the Department of Social Services responsible for assisting Missouri's most vulnerable citizens: Family Support Division, Children's Division, Division of Medical Services and Division of Youth Services. There are four administrative support divisions within the Department of Social Services: Division of Budget and Finance, Information Services & Technology Division, Division of General Services and Division of Legal Services. The directors of these four divisions operate as a management team to provide assistance and support to the entire department.

#### ADMINISTRATIVE SUPPORT DIVISIONS

#### Division of Budget and Finance

The Division of Budget and Finance (DBF) is responsible for providing budgetary and financial support services to all divisions within DSS. The responsibilities of DBF can be divided into the following areas: accounts payable, audit, budget, payroll, receipts and reporting, and purchasing.

#### Information Services & Technology Division

The Information Services & Technology Division (ISTD) provides data services to all divisions within DSS. These services include planning and coordinating all data processing activities as well as the development, maintenance and operation of the department's computer systems.

#### **Division of General Services**

The Division of General Services (DGS) provides a wide range of support services to all divisions and divisional offices located throughout the state. DGS is responsible for building maintenance and leasing, inventory control and supply distribution, mailing, warehousing, composing and printing, and telecommunications.

#### Division of Legal Services

The Division of Legal Services (DLS) provides legal, investigative and audit services to DSS. The responsibilities of DLS can be divided into the following areas: legal, welfare and Medicaid investigation, compliance, and internal audit.

The Family Support Division (FSD) exists to provide a continuum of support for families. FSD's goal is to assist families in obtaining self-sufficiency and maintaining or improving their quality of life. FSD accomplishes this goal for the children and families of Missouri by providing the best possible services to the public.

FSD services include: Income Maintenance and Self-sufficiency programs, including the Food Stamp, Temporary Assistance and Medicaid programs; Rehabilitation Services for the Blind; and the Child Support program. Other programs include: Community Services Block Grant Programs; Low Income Home Energy Assistance; Refugee Resettlement; and Supplemental Nursing Care.

FSD is the largest of the agencies assigned to DSS. Offices are located in each of the 114 Missouri counties and in the city of St. Louis.

CD works with all parties to safely maintain children in their homes whenever possible and to secure safe, permanent living arrangements when out-of-home placement is necessary.

CD administers the Child Abuse/Neglect Hotline, School Violence Hotline, Intensive In-Home Services, Family Centered Services, Adoption Services, Independent Living, Foster Care, Residential Licensing and preventive services including Early Head Start, Stay-at-Home Parent Program, Child Care Start-Up and Expansion Program, Child Care Subsidy, and other early childhood and early intervention strategies. CD is responsible for the assessment and investigation of all reports to the Child Abuse/Neglect Hotline.

The Division of Medical Services (DMS), established in 1985 under the Department of Social Services Reorganization Plan, administers the Missouri Medicaid program authorized under Title XIX of the Social Security Act and enacted by state legislation. Professional and technical consultation is received from a medical advisory committee and subcommittees.

Medicaid is a program of medical assistance for the poor jointly funded by state and federal funds. Its goal is to provide health care for needy individuals through payment to providers of medical goods and services. In addition to reimbursing vendors for the provision of services, DMS also pays insurance premiums, deductibles and co-payments for certain aged and disabled Medicare beneficiaries.

Major services provided through the Medicaid program include inpatient and outpatient hospital services; nursing home care; physician and pharmacy services; laboratory and x-ray; home health; audiology, dental, optometric and podiatry; ambulance services; adult day health care; personal care services; nurse-midwife, nurse practitioner services; hospice services; case management services for pregnant women and children; durable medical equipment, orthotic and prosthetic devices; and ambulatory surgical centers.

The Division of Medical Services also administers the Healthy Children and Youth program, a comprehensive medical program focusing on primary and preventive services for individuals up to age 21. Through the program, children receive medical, hearing, dental, and eye examinations; appropriate laboratory tests; immunizations; lead screens; and referral for follow-up care for evaluations of problems detected during a screen.

The Division of Youth Services (DYS), established in 1974 with the creation of the Department of Social Services, provides a range of services to youths who have been committed to DYS by the juvenile court system and are in need of rehabilitative and educational services. Chapter 219, RSMo further defines the responsibilities of DYS to include the prevention of delinquency; the provision of incentive subsidies to juvenile courts; consultation and information services to non-DYS agencies; and technical assistance to local communities.

The Divsion of Youth Services serves youths ages 17 and under who have been adjudicated as status or delinquent offenders. Once committed to DYS, youths can be held until age 21. Most sentences are indeterminate, with youths assigned to a facility until they are approved for return to their homes under supervision of DYS' aftercare program. DYS operates several programs with varying levels of security throughout the state, including group homes, park camps, specialized residential programs and non-residential community-based programs. Other services include case management, intensive case monitoring, proctor care and family therapy.

Implemented in the late 1970's, the Juvenile Court Diversion program is intended to divert the less serious offenders from the Division of Youth Services and allow the courts to work with these youths and their families in their home communities.
